RESOLUTION NO. 397

RESOLUTION OF INTENTION TO ISSUE ECONOMIC DEVELOPMENT REVENUE BONDS (WAYMAN FIRE SPRINKLER, INC. PROJECT); 403 MECO DRIVE, BOXWOOD INDUSTRIAL PARK, WILMINGTON, DELAWARE

WHEREAS, Council of New Castle County (the County) has heretofore adopted the New Castle County Commercial, Industrial and Agricultural Ordinance, Ordinance No. 80-045, as amended, New Castle County Code, Art. VIII, Div. 2, §7-91, et seq., (the General Ordinance) to encourage and assist the financing of the construction, acquisition, sale or lease of industrial, commercial and agricultural facilities related to the maintenance or promotion of employment or to the redevelopment or revitalization of areas within the County; and

WHEREAS, Duane L. Wayman, II and Maryanna Wayman, individuals residing in Wilmington, Delaware (the Applicants), have submitted to the County through the Executive an application (the Application) for the financing of a project consisting of the acquisition of approximately 1.07 acres and an existing building (approximately 7,150 square feet), the renovation thereof and the construction of an addition thereto and the acquisition of equipment associated therewith located at 403 Meco Drive, Boxwood Industrial Park, Wilmington, Delaware, to be leased to Wayman Fire Sprinkler, Inc., for use as administrative offices and additional fabrication and storage facilities (the Project) and have requested the County to finance a portion of the costs of the Project, an estimate of which is attached as Exhibit A hereto (the Costs), said financing to be accomplished through the issuance by the County of Economic Development Revenue Bonds in the aggregate principal amount not to exceed \$250,000 (the Bonds); and

WHEREAS, the Application has been reviewed by a committee comprised of the Chief Administrative Officer, the Director of Finance, the County Attorney, the Director of Planning, and Council's Auditor (the Review Committee); and

WHEREAS, the Applicants have submitted with the application a conditional commitment for the purchase of the Bonds from Delaware Trust Company; and

WHEREAS, the Review Committee has made the findings and determinations required by the General Ordinance, including the findings that

- (a) the Project is eligible for financial assistance and the financing thereof will accomplish the public purposes contemplated by the General Ordinance;
- (b) the Project will (i) tend to maintain or provide gainful employment opportunities within and for the people of the County; (ii) aid, assist and encourage the economic development or redevelopment of the County; and (iii) maintain, diversify or expand employment promoting enterprises within the County; and
- (c) the Bonds are to be issued for a Project which will be leased to, sold to, or financed for financially responsible Persons who have not been finally determined by any state or federal agency or court to have committed (i) illegal conduct involving moral turpitude or (ii) a major labor law violation, during the period commencing two (2) years prior to the approval of the Persons' application for assistance and ending on the date of the issuance of the bonds by the County; and
- (d) the Bonds are to be payable solely from Revenues as specified in the General Ordinance; and

WHEREAS, the Review Committee has advised the Executive of its findings and determinations; and

WHEREAS, the Executive has advised the Applicants of the Review Committee's findings and determinations; and

WHEREAS, the Executive has advised the Council of the Review Committee's findings and determinations and has transmitted the Application to the Council; and

WHEREAS, the Council has determined that the Project be completed at the earliest practicable date, and recognizes that the Applicants require satisfactory assurances from the County that the proceeds of the sale of the Bonds will be made available to finance the Project; and

WHEREAS, the Council deems it necessary and advisable that it take such official action as may be required under the General Ordinance, to authorize the issuance and sale of the Bonds.

NOW THEREFORE BE IT RESOLVED:

1. The Council hereby authorizes the issuance of the Bonds for the purpose of paying a portion of the Costs of acquisition, construction and installation of the Project.

- 2. In order to facilitate the commencement of the Project, the Council hereby determines that the purposes of the Ordinance will be more effectively served if the Applicants enter into contracts for the commencement of the Project as soon as practicable. The County intends to reimburse the Applicants from the proceeds of the sale of the Bonds for Costs of the Project incurred subsequent to the passage of this Resolution and prior to delivery of the Bonds.
- 3. Subject in all respects to the prior advice, consent and approval of the Applicants, the County Executive is hereby authorized and directed to prepare or cause to be prepared and to execute and file on behalf of the County any applications, filings and certifications, and take such other action as such officers may deem necessary or advisable to obtain approvals of the Project, to provide for the issuance of the Bonds and to establish that the interest on the Bonds is exempt from Federal income taxes. In addition, the County Executive is hereby authorized and directed to prepare or cause to be prepared and to be executed and filed on behalf of the County all documents, certifications and filings required by the laws of the United States and The State of Delaware necessary or appropriate in order to implement and carry out the matters herein authorized or required by the General Ordinance.
- The County's obligations hereunder shall be contingent upon the issuance of a final commitment to purchase the Bonds and all obligations of the County hereunder shall be satisfied solely from the proceeds of the sale of the Bonds. Approval of this Resolution shall in no way preclude the Council from independent consideration (and denial) of any application relating to the land use aspects of the Project (e.g. zoning matters). Issuance of the Bonds shall be made in accordance with the terms of a Project Resolution which the Council shall adopt after the issuance of a final commitment which shall provide for repayment in not more than 30 years at a rate of interest prevailing at the time of the issuance of the Bonds. The Applicants shall have the full responsibility to obtain the issuance of such a final commitment. The County shall have no responsibility to seek the issuance of such a commitment. County's obligations hereunder shall terminate six (6) months from the effective date hereof. Approval of this Resolution does not obligate the County to allocate any of its private activity bond limit under Internal Revenue Code Section 103(n) and provided further that if the Bonds are not issued prior to January 1, 1986, the County specifically reserves the right to review the authorization of the issuance of the Bonds with respect to the allocation of any "private activity bond limit" if required under Internal Revenue Code \$103(n).

5. This resolution shall take effect upon its passage by Council.

SYNOPSIS: This Inducement Resolution expresses the County's intent to issue economic development revenue bonds in an amount not greater than \$250,000 for the financing of a project for Duane L. Wayman, II and Maryanna Wayman consisting of the acquisition of approximately 1.07 acres and an existing building (approximately 7,150 square feet), the renovation thereof and the construction of an addition thereto and the acquisition of equipment associated therewith located at 403 Meco Drive, Boxwood Industrial Park, Wilmington, Delaware, to be leased to Wayman Fire Sprinkler, Inc., for use as administrative offices and additional fabrication and storage facilities (the Project) and authorizes the Applicants to proceed with the Project in reliance on this commitment. The Bonds will actually be issued pursuant to a subsequent Project Resolution of Council which will set out the detailed terms of the bond issuance and will approve the loan documents involved in the transaction. terms of the bond issuance will be tailored to meet the terms of the final commitment to purchase the Bonds. The County has no obligation to issue the Bonds unless the Applicants obtain such a commitment and, in any event, any obligation of the County may be satisfied solely from the proceeds of the sale of the Bonds. The Applicants have the sole responsibility to obtain such a final commitment.

FISCAL NOTE: This Inducement Resolution commits the County to issue its economic development revenue Bonds subject to further approval of the documentation by County Council. Pursuant to contract with the County, the New Castle County Economic Development Corporation (NCCEDCO) administers the County's Economic Development Revenue Bond Program. For its services, and to assist its economic development activities within the County, the County has caused the applicants to pay NCCEDCO an application fee of \$250 and, upon the sale of the bonds, the Applicant will pay NCCEDCO an additional financing fee equal to 1/2 of 1% of the principal amount of the bonds (i.e. \$1,250). In connection with this Project the County will receive a building permit fee of \$264.21 plus a certificate of occupancy fee of \$25. The applicants pay all legal and other fees associated with the bond financing.

The Bonds contemplated by this resolution will be limited obligations of the County, which will not constitute or give rise to any pecuniary liability of the County other than from the revenues derived from the Project financed, which will be specifically pledged to payment of principal and interest on the Bonds.
